

On November 14th, sixteen Legal Outreach students, male and female, visited the NFL's headquarters for a professional exposure workshop. Professionals from various departments within the NFL spoke about their career paths and the different opportunities within the corporation,

including those related to litigation, intellectual property, finance, and graphic design. Students received a primer on American professional football, after which they were split into groups and worked through a hypothetical problem with the assistance of NFL employees. On the importance of exposing diverse students to opportunities within the NFL, Ms. DiBella said,

"Our partnership with Legal Outreach is a prime example of how the NFL works to promote opportunities for young people, particularly those who grow up in diverse communities.
