The Honorable Roger L. Gregory

Chief Judge, 4th Circuit

Chief Judge Roger L. Gregory is the first African American to serve on the United States Court of Appeals for the Fourth Circuit. He initially received a recess appointment from President William J. Clinton and then was re-nominated by President George W. Bush and confirmed by the Senate for a lifetime appointment. In 2016, Judge Gregory became the first African American to serve as the Chief Judge of the Fourth Circuit. Judge Gregory has authored or joined several landmark decisions, including the en banc decision declaring the 2017 Muslim travel ban unconstitutional, the decision declaring Virginia's same-sex marriage ban unconstitutional, and the decision upholding the tax subsidies for health insurance purchased on federal exchanges under the Affordable Care Act.

Sheila S. Boston

Immediate-past President of the NYC Bar Association

Sheila Boston, a graduate of Princeton University and Columbia Law School, is a litigation partner at Arnold & Porter Kaye Scholer LLP. She has been recognized by several publications and organizations for her work in the product liability arena, her pro bono service, and her advocacy for diversity, equity and inclusion. She is the recipient of numerous awards and accolades including the New York Law Journal's Lifetime Achievement Award. Ms. Boston just recently completed a two-year term as President of the New York City Bar Association where she was the first woman of color to serve as the organization's President in its 152 year history.

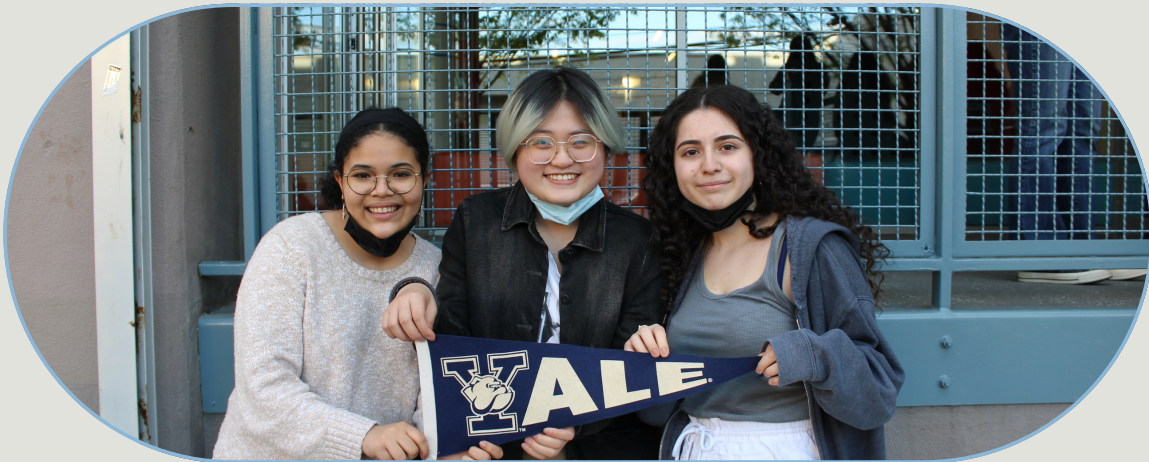

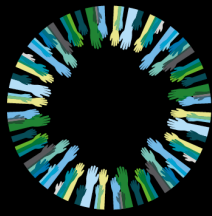
