OUR MISSION

Legal Outreach seeks to change the higher educational and career trajectory for minority, low income, and first-generation students by implementing programs designed to fill the achievement, outlook, support, college matching and leadership gaps which prevent students from achieving their highest aspirations and professional goals.

OUR PROGRAMS

To achieve diversity within any profession, early intervention in the lives of underrepresented groups is a necessity. Legal Outreach thus recruits high potential eighth graders from underserved communities and immerses them in a five-week **Summer Law Institute (SLI)** in partnership with six law schools. Upon completion, the SLI participants apply for admission to **College Bound**, Legal Outreach's four-year, intensive academic skill development and support program designed to prepare them for the rigors of college and professional careers. Meeting after school, on Saturdays and during the summers, students spend over 2,300 hours building and sharpening the skills needed for success.

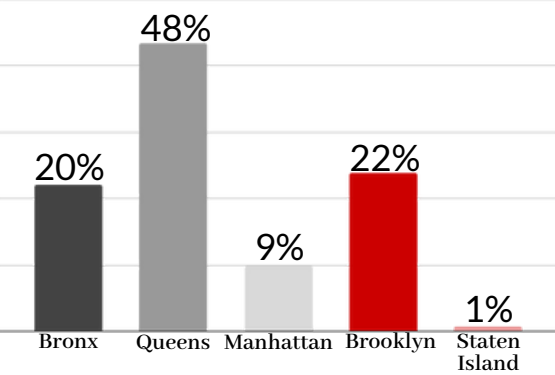

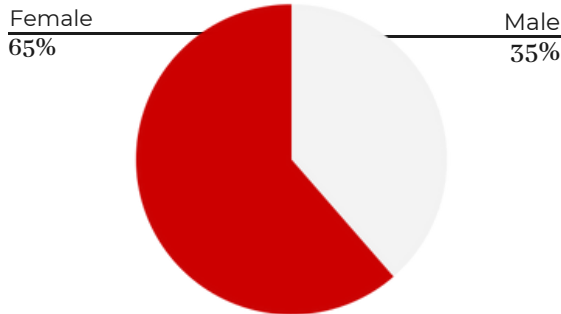

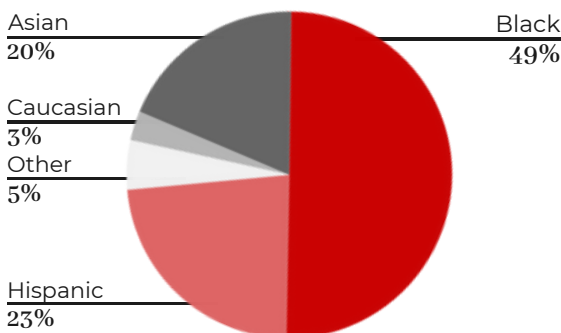
Students by Borough

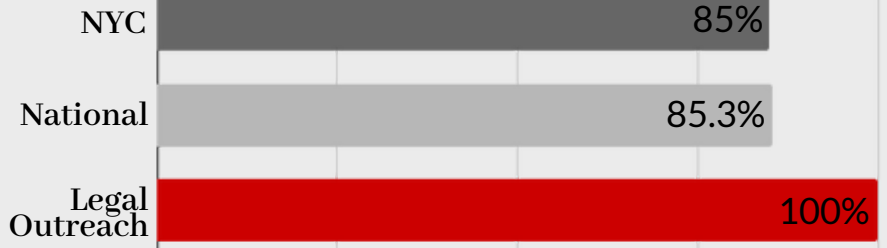


Ethnicity
Classes 2013 - 2023



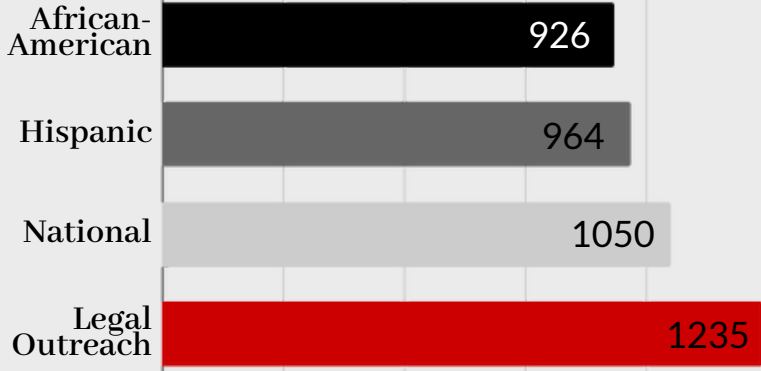
HIGH SCHOOL GRADUATION RATES

Classes 1993 - 2023



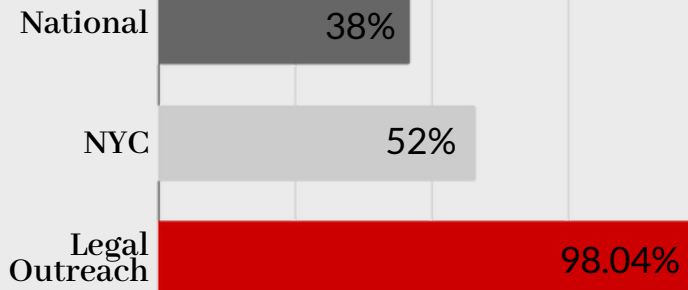
AVERAGE SAT SCORES

Classes 1993 - 2023



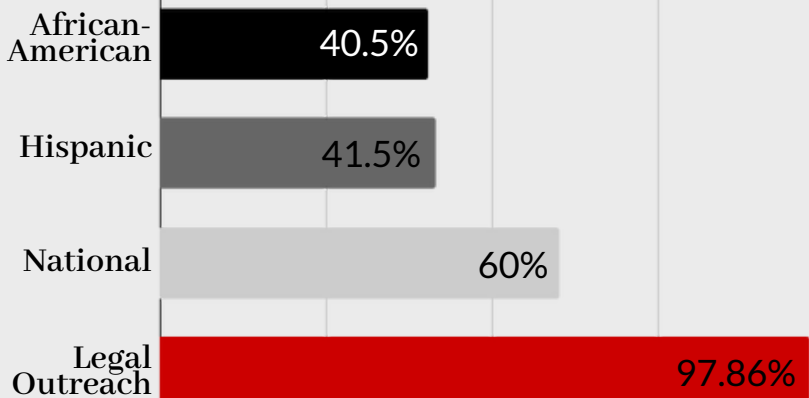
MATRICULATION RATE TO MOST, HIGHLY & VERY SELECTIVE COLLEGES
