IN 2023-24, LEGAL OUTREACH SERVED A TOTAL OF 397 STUDENTS, INCLUDING 159 STUDENTS IN THE SUMMER LAW INSTITUTE, 35 ALUMNI, AND 203 STUDENTS IN THE COLLEGE BOUND PROGRAM. WITHIN THE COLLEGE BOUND PROGRAM, WE CONTINUE TO IMPLEMENT OUR SCHOOL-YEAR ACADEMIC ADVISORY PROGRAM, WRITING PROGRAM, CON LAW DEBATE PROGRAM, MENTORING PROGRAM, PROFESSIONAL TRAINING PROGRAM, PROFESSIONAL EXPOSURE PROGRAM, PARENTAL SUPPORT PROGRAM, COLLEGE ADMISSIONS PROGRAM, TRANSITION-TO-COLLEGE, AND CIVIC ENGAGEMENT AND SOCIAL JUSTICE PROGRAM.
